A RESOLUTION

ADDRESSED TO THE HONORABLE SENATOR MARK A. VILLAR, SENATE OF THE REPUBLIC OF THE PHILIPPINES, REQUESTING FOR THE ALLOCATION OF FUNDS FOR THE IMPROVEMENT, EXPANSION OF THE MULTI-PURPOSE HALL, EVACUATION CENTER AND COMMAND CENTER AT THE GUIUAN MUNICIPAL HALL COMPLEX, GUIUAN, EASTERN SAMAR, IN THE AMOUNT OF FIFTY MILLION PESOS (PHP50,000,000.00).

WHEREAS, the Municipality of Guiuan is constructing an evacuation center with command center and multi-purpose hall within the municipal compound;

WHEREAS, the construction of the building aims to address the lack of resilient evacuation center where evacuees could take shelter during times of imminent disaster and risk of damage to lives and properties;

WHEREAS, the municipality's budget allocation for the project is limited and not enough to complete the project and make it operational and functioning to serve its purpose especially in these times when typhoons are projected to be more intense and stronger;

NOW THEREFORE, on motion Hon. Mary Charmaine G. Villar, duly seconded by Hon. Josue P. Sison;

BE IT RESOLVED, As It Is Hereby Resolved to Request the Honorable Senator Mark A. Villar, Senate of the Republic of the Philippines, for the Allocation of Funds for the Improvement, Expansion of the Multi-purpose Hall, Evacuation Center and Command Center at the Guiuan Municipal Hall Complex, Guiuan, Eastern Samar, in the Amount of Fifty Million Pesos (Php50,000,000.00)

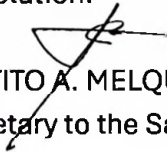

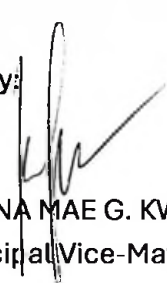
