A RESOLUTION

**RESPECTFULLY REQUESTING THE HON. CONGRESSMAN CHRISTOPHER SHEEN
GONZALES, REPRESENTATIVE OF THE LONE DISTRICT OF EASTERN SAMAR TO
ALLOCATE FUNDS IN THE AMOUNT OF FORTY-FIVE MILLION PESOS
(P45,000,000.00) FOR THE IMPROVEMENT AND REHABILITATION OF THE GUIUAN
PORT AND ITS FACILITIES LOCATED AT MORERO DRIVE, BRGY. 06, GUIUAN,
EASTERN SAMAR.**

WHEREAS, the Municipality of Guiuan can be considered a Port Town as it hosts two important ports and some other lesser known but equally important ports;

WHEREAS, its distinction as a Port Town is anchored on its geographical characteristic as a peninsula with five (5) islands consisting of at least nineteen (19) barangays;

WHEREAS, historically, the Guiuan Port was once the main port when travel from Tacloban and other cities and municipalities was through boat, while presently, the island barangays can only be accessible through boats that use the Guiuan Port as the main docking and berthing area;

WHEREAS, while the Guiuan Port is again being used as the main landing area for passenger boats plying the routes from Tubabao, Manicani, Homonhon and Suluan, it is still wanting in compulsory and mandatory required facilities and passenger amenities;

NOW THEREFORE, on motion en masse of the majority of the members present, duly seconded by the same;

BE IT RESOLVED, As It Is Hereby Resolved, to Respectfully Request the **Hon. Congressman Christopher Sheen P. Gonzales**, *Representative of the Lone District of Eastern Samar* to Allocate Funds in the Amount of **Forty-Five Million Pesos (P45,000,000.00)** for the **Improvement and Rehabilitation of the Guiuan Port and its Facilities** Located at Morero Drive, Brgy. 06, Guiuan, Eastern Samar.
