A RESOLUTION

ENDORSING AND INTERPOSING NO OBJECTION TO THE CONSTRUCTION OF A 3MW
SOLAR POWER PLANT FARM PROJECT OF THE EASTERN SAMAR ELECTRIC
COOPERATIVE (ESAMELCO) AND ITS PARTNER TAFT HYDRO-ELECTRIC COMPANY IN
BARANGAY TIMALA, GUIUAN, EASTERN SAMAR.

WHEREAS, ESAMELCO together with its partner Taft Hydro-Electric Company are
exploring the probability of constructing a 3MW Solar Farm Power Plant in Guiuan,
particularly in Brgy. Timala;

WHEREAS, the project of a renewable energy exploration in Guiuan will definitely help in the mitigating the worsening electric power problem in Guiuan and its nearby municipalities;

WHEREAS, a clean energy from the Sun is a welcome development even if its capacity is still short of the increasing power requirement of the cluster which presently is almost at 3.5 to 4.0 MW for Guiuan alone;

NOW THEREFORE, on motion of Hon. Francis Aldous B. Sison, duly seconded by Hon. Floriano G. Bagro, Jr. and Hon. Antonia R. Cablao;

BE IT RESOLVED, As It Is Hereby Resolved, to Endorse and Interpose No Objection to the Construction of a 3MW Solar Power Plant Farm Project of the Eastern Samar Electric Cooperative (ESAMELCO) and its Partner Taft Hydro-Electric Company in Barangay Timala, Guiuan, Eastern Samar.

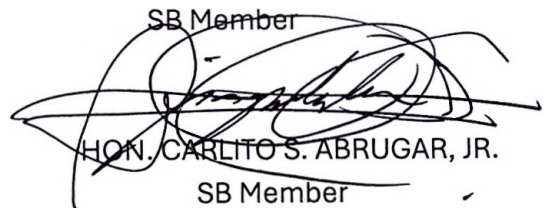

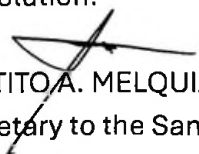

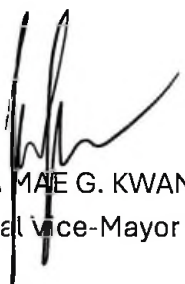
