WHEREAS, Republic Act No. 11291, otherwise known as “*Magna Carta for the Poor*” provides that it is the declared policy of the State to uplift the standard of living and quality of life of the poor;

WHEREAS, the Kapit-Bisig Laban sa Kahirapan Comprehensive and Integrated Delivery of Social Services (KALAHI-CIDSS), is one of the anti-poverty programs of the DSWD that works through a localized and participatory process in marginalized and vulnerable communities;

WHEREAS, the Local Government Code of 1991 or RA 7160 (Sec. 16) allows LGUs to exercise powers not only explicitly but also impliedly for the necessary, appropriate or incidental powers for efficient governance;

WHEREAS, Sec. 447 (a)(1)(iv) of RA 7160 empowers the Sangguniang Bayan to adopt measures to protect the inhabitants of the municipality from the harmful effects of man-made or natural disasters and calamities and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events;

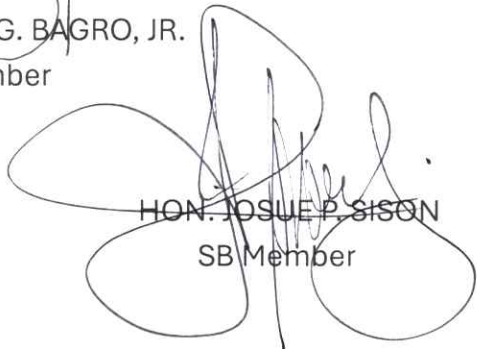
NOW THEREFORE, on motion of Hon. Mary Charmaine G. Villar, duly seconded by Hon. Floriano G. Bagro, Jr.;

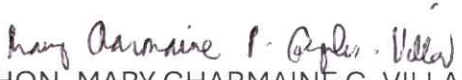
