A RESOLUTION
EXTENDING THE DEADLINE OF PAYMENT OF TAXES, FEES AND CHARGES IN
SECURING BUSINESS PERMITS OF BUSINESS ESTABLISHMENTS OPERATING IN THE
MUNICIPALITY OF GUIUAN, EASTERN SAMAR FROM THE JANUARY 20, 2026 TO
JANUARY 30, 2026.

WHEREAS, the Local Government Unit (LGU) accedes to the request and insistent public demand for an extension of the deadline of payment of fees, charges and taxes relative to securing business permits and licenses;

WHEREAS, the Business Permit and Licensing Officer (BPLO) requested for the extension of the deadline in consideration of the delay in the payment of taxes, fees and charges among business owners for certain valid reasons affecting the rate of business tax and permit payments such as the long weekend at the start of the year and the delay brought by Tropical Storm ADA;

WHEREAS, notwithstanding the granting of the request for the extension, the Sangguniang Bayan continues to monitor the status of payment if another extension is recommended based on the situation as assessed by the proper authorities;

NOW THEREFORE, on motion Hon. Rogelio O. Cablao, duly seconded by Hon. Francis Aldous B. Sison;

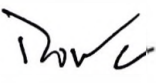

ADOPTED AND APPROVED: January 14, 2026, at Guiuan, Eastern Samar.

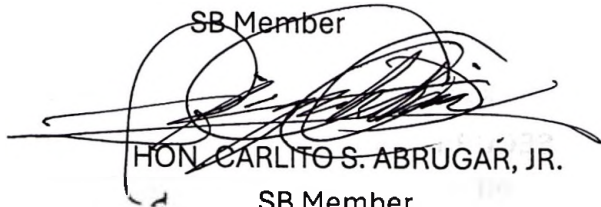
