A RESOLUTION

**TO GRANT AUTHORITY TO THE LOCAL CHIEF EXECUTIVE TO ENTER A
MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT SOCIAL WELFARE AND
DEVELOPMENT REGIONAL FIELD OFFICE NO. VIII OR DWSD FO VIII FOR THE
IMPLEMENTATION OF THE “WALANG GUTOM 2027: FOOD STAMP PROGRAM” IN
THE MUNICIPALITY OF GUIUAN, EASTERN SAMAR.**

WHEREAS, the “Walang Gutom 2027: Food Stamp Program” aims to help address food insecurity and improve the nutritional well-being of economically vulnerable households in the municipality through strengthened collaboration between the national government and the local government unit;

WHEREAS, the “Walang Gutom 2027: Food Stamp Program” was declared a flagship program of the national government by virtue of Presidential Executive Order (EO) No. 44, series of 2023 and designating the DSWD as the lead implementing agency;

WHEREAS, the “Walang Gutom 2027: Food Stamp Program” aims to decrease the incidence of involuntary hunger experienced by low-income families through the provision of Electronic Benefit Transfer (EBT) Cards which can be used to purchase select food commodities at eligible partner stores and merchants;

WHEREAS, the Local Government Unit is tasked to implement and support the Walang Gutom 2027: Food Stamp Program in accordance with the policies, standards, and implementing guidelines issued by the DSWD, ensuring that all program activities within its jurisdiction are carried out with transparency, accountability, and integrity, and in full cooperation DSWD Field Office VIII;

BE IT RESOLVED, As It Is Hereby Resolved, to Grant Authority to the Local Chief Executive to Enter a Memorandum of Agreement with the Department Social Welfare and Development Regional Field Office No. VIII or DSWD FO VIII for the Implementation of the “Walang Gutom 2027: Food Stamp Program” in the Municipality of Guiuan, Eastern Samar.

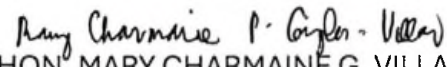

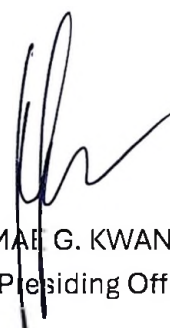
