AN ORDINANCE

**RENAMING THE RURAL HEALTH UNIT I, TB-DOTS, AND RHU I BIRTHING FACILITY TO
GUIUAN PRIMARY CARE FACILITY FOR A UNIFIED APPLPLICATION FOR LICENSING
WITH THE DEPARTMENT OF HEALTH (DOH).**

WHEREAS, the Local Health Board submitted Resolution No. 01, Series of 2026 that seeks to request the Sangguniang Bayan to issue or pass a legislative measure for the renaming of the Rural Health Unit I, TB-DOTS, and the RHU I Birthing Facility to Guiuan Primary Care Facility;

WHEREAS, the Rural Health Unit I of Guiuan is preparing for the licensing of the facility into a Primary Care Facility to comply with the documentary requirements set by the Department of Health;

WHEREAS, the facility is to be renamed Guiuan Primary Care Facility to encompass the ancillary services provided by the RHU and for a unified application for License to Operate;

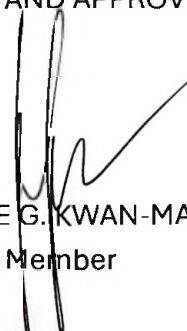

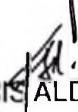
BE IT ORDAINED, By This Sangguniang Bayan in its Regular Session assembled, that –

Section 2. Coverage. The **Guiuan Primary Care Facility** shall cover the **RHU I**, the **TB-DOTS** and the **RHU I Birthing Facility**.

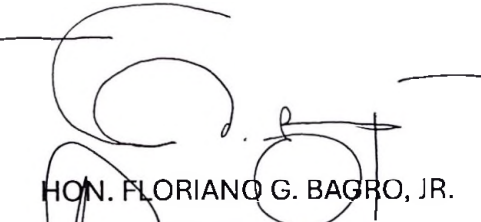
